## LATTA FIRE DEPARTMENT REQUEST

The quote is from Quinn's Covenant Cars for a 2002 Ford F350 4X4 Doolie. **Aron Gandy motioned to approve purchasing the truck (cost \$15,195.00).** He stated he had not looked at the truck but the fire department has and the bank books show it is worth the price. **Bobby Moody seconded and all were in favor.**

#### FINANCE REPORT

Mr. Young told that financial information was given at the last meeting. He told that revenue numbers had met budget projections to date. He also told that he hoped to get the information onto our web page in the future along with other reports. He stated that he had sent out a memo to department heads concerning fuel reports and directing them to reinstate use of the log/fuel forms.

## **COMMITTEE REPORTS**

Mr. Graves told that the Building Committee had not been able to meet since the last meeting but will try to meet soon.

## **ADMINISTRATOR'S REPORT**

Mr. Young told that we have talked about applying for a \$1,000,000 RIF grant from SC Department of Commerce for a spec building for the Tri-County I-95 Gateway Industrial Park. He told that the estimated cost of the building is \$2.5 million and that all three counties have committed to the application. He believes the Coordinating Council will meet on November 3<sup>rd</sup> to discuss the grant.

## **COUNTY ATTORNEY'S REPORT**

Mr. Dubose stated that he needed to have a discussion with Council in executive session prior to their consideration of third reading of the road ordinance (legal matter). He also informed Council of DHEC making "bath salts" illegal, as schedule 1 controlled substances, on October 24. 2011 and that the State of SC may pass a law to cover this also.
